When you read what Sheriff Hart said at the end of the report, you may wondering whose side he is on ("However, due to the strong cultural tradition of celebrating the Declaration of Independence with fireworks, we faced headwinds"). Huh? So what?!

There are 168 of you receiving this email. It is difficult to get to a weekday meeting, so no worries if you cannot

attend and speak your mind about the lack of citations. Instead, *please consider emailing* your supervisor no later than Sunday night. Your emails will be seen by the supervisors!! We need a lot of emails asking that the County step up and cite violators in order to send a clear message to those who continue to use fireworks that they will be fined for breaking the law. 100 emails would make a statement that the BOS can not ignore. Let's go for 100 at least!

Let's also be sure to say what we liked about the efforts the County made - because they did put forth effort, especially regarding their education and awareness campaign. They spent \$6,800 on media efforts and should be thanked. Too bad the deputies who witnessed violations of the fireworks ordinance didn't issue many citations -- they could have recovered some of the money the County invested.
